

# **Rembrandt Living Home Care Fees**

Home care fees are set by the Australian Government and made up of the:

- · Consumer Contribution; and
- Income Tested Fee (if applicable)

The fees are payable by a home care package consumer monthly in advance to Rembrandt Living as the home care package provider.

The consumers' fees are added to the eligible subsidies paid by the Government to make up the total funds available to a home care consumer.

### **Home Care Package Administration**

#### **Cancellation Process for all Service Bookings**

Rembrandt Living requires a minimum of 24 hours (business hours) notice of intention to cancel a service booking. If less than 24 hours notice is received the full cost of the service will be charged.
