

### AGED RIGHTS ADVOCACY SERVICE (ARAS)

Aged Rights Advocacy Service (ARAS) is a free, confidential and statewide service which has been operating since 1990. ARAS supports older people and their legal representatives who are:

- living in residential aged care, at home or in a retirement village
- at risk of, or experiencing abuse from family, friends, carers or service providers
- receiving Commonwealth Home Support Programme (CHSP) or Home Care Package (HCP) services.

Some people may feel confident in raising their concerns with a service provider without the support of a formal advocacy service; this is called selfadvocacy. You have a right to ask questions, and to be consulted about your services. Your feedback and communication assists service providers to improve the quality of their service, and may assist other people who may have similar issues.

Although ARAS encourages people to self-advocate where they feel comfortable to do so, please feel free to call ARAS if you need further information or support.

#### **BOARD MATTERS**

The Board meeting was held on Wednesday 2nd August 2023 at Rembrandt Court with all Board members in attendance.

The CEO facilitated an Aged Care Awareness Activity which including a video of a staff member and a Resident. This activity was filmed during a dementia training session. We are well on our way to becoming a Teepa-Snow accreditated organisation.

An update was provided to the Board on various activities from the Strategic Plan Action Plan which are currently underway including Focus Group meetings on Digital Transformation; a Cybersecurity Report and Star Ratings.

The General Manager, People and Culture (Fiona Rosman) presented to the Board a draft 'Strategic Workforce Plan Roadmap' framework which is designed to ensure Rembrandt Living continues to employ the best people for our organisation. It includes mentoring and training to upskill individuals as well as thinking outside the square in promoting innovative ideas in the approach to our future workforce.

The Board were advised there was no further updates in relation to the Doreen Street project.

The Board discussed this at length and wish to investigate some changes to the constitution to be presented to the Members at this year's AGM.
