The Board meeting took place on Wednesday, 6th December, in the Rembrandt Court Board Room. There was only one apology from Marie Wood, who is currently enjoying a lovely holiday in New Zealand. When the board meets at Rembrandt Court, they are provided a meal from the kitchen. Jo West and her team were complimented on the delicious meal, which was also enjoyed by the residents that day!

A debrief of the Annual General Meeting, held at the Marion Hotel was conducted. The Board agreed that the night was enjoyable but expressed disappointment with the numbers in attendance.

The Board was also advised that the purchase of the 'Doreen Street' property has progressed, with a settlement date in December 2023.

Sinterklaas Feste was held at Rembrandt Court on Friday, 1st December. Sef, the Board Chair, stepped in at the last moment (due to illness) to play Sinterklaas. Sef mentioned how much fun the residents had and expressed what a pleasure it was to play the role of Sinterklaas (see pictures below). Thank you Sef!

The board discussed the new governance requirements and agreed with the approach of creating another two committees, a Home Care Quality Care Advisory Committee (HCQCAC) and a residential QCAC (RQCAC). The new QCACs will meet quarterly and will be trialled for a 6 month period.

The CEO reported that we have reintroduced mask wearing at Rembrandt Court. She also reported that event planning is well underway for the Teepa 24 Dementia Conference, scheduled to be held at the Morphetville Racecourse in the new Wolf Blass Event Centre on March 19, 2024.
